





Club Constitution

General rules and regulations

1. Membership subscription:

- **1.1.** visitors, willing to become members, must fill, sign, and submit a membership application form, once they have registered in the web page. The organization is registered under the LPPD (Law for Protection of Personal Data).
- **1.2.** the membership subscription is personal, and it is not to be provided to other parties. It is highly recommended that club members do not purchase goods from the bar with discounts to customers who are not club members.
- **1.3.** club membership activation or renewals are done from 09:00 to 19:00 o'clock on the same day, when the signed agreement is submitted, or on the next working day at the latest.
- **1.4.** any member may discontinue their membership at any given time, but Powwow club does not provide any compensation for that.
- **1.5.** Powwow club may terminate the membership status of any member whose actions deliberately violate the listed rules and regulations.
- **1.6.** membership subscriptions are monthly based, and their duration starts counting from the payment date. Users, who have their subscriptions expired, are considered regular visitors, and are not entitled to additional services and products.
- **1.7.** for upgrading to a higher membership level, the current membership duration is taken into consideration. Up to 15 (fifteen) days, since the beginning of the current subscription, the member needs to add enough money to cover the extra cost; once the fifteen-day period is passed, the member has to provide the whole sum, needed for the higher membership level and a new full month period starts from this date.
- **1.8.** money, which remained in the personal club account, after an expiration of a membership subscription, is kept private in the personal club account. These funds can be utilized by the user in the form of products and services on regular (not discounted) prices, but cannot be refunded.
- **1.9.** the first membership card is issued free of charge. Provided that the card is lost, the cost of issuing a new one is 5 leva (VAT included).





1.10 each club member can receive non-fiscal receipt for each of his/her purchases at the bar in Cybar. To do so, he/she must activate this option in his/her profile on www.powwow.bg

1.11. our POWWOW BODY & CULTURE club members may receive an extra membership card, which is to be used by their child.

This extra card:

- is assigned to the profile of an active club member, and the responsibility for the proper usage, and the consequences as well, are borne entirely by the member to whom it is assigned;
- provides access to the gym only;
- is provided for the sheer convenience of the parents;

It should be noted that this card can neither be used for purchasing discounted goods from the bar, nor for accessing the gaming stations.

2. Responsibilities of members:

- **2.1.** to provide accurate and valid information when filling out the membership application form.
- **2.2.** to get well acquainted with the agreements for using the equipment and facilitites, to agree with the agreements, and sign them.
- **2.3.** to register every visit to the gym, or the academy. In order to do that, members use their personal RFID chips, while visitors should contact any personnel of the center.
- **2.4.** to behave in a way that does not disturb the convenience and safety of the other visitors, and the personnel of the center, as well.
- **2.5.** to protect the property and equipment of Powwow club.
- **2.6.** to be responsible for the condition and the safely storage of their personal belongings ID cards, money, tech equipment, jewelry, and any other valuable items. Powwow club is not to be held responsible for lost or stolen personal items.
- **2.7.** to not carry out property and equipment, which do not belong to them.

3. It is strictly prohibited:

- **3.1.** flame igniting and smoking in any of the premises of the center.
- **3.2.** importing of illicit and controlled substances.
- **3.3.** importing of: weapons, firearms, ammunition, hazardous chemicals, and highly flammable substances.
- **3.4.** allowing pets inside the premises of the center.
